## HISTORY

The Northern Virginia Amateur Championship was started in 1974 by Henry Kerfoot at the request of then Northern Section chairman Jack Redinger. In the early years of the event prizes were awarded to the winner and runner-up only with the next eight finishers receiving engraved pewter beer mugs. In those early days it was more about the prestige of being a top ten “finalist” than the prizes. Henry succeeded Jack Redinger as Northern Section chairman and the event remained fairly unchanged until Gil Fitzhugh succeeded Henry as chairman. Under Gil’s direction the prize concept changed to include merchandise which helped increase the size of the fields. The Northern Section of the VSGA has now grown into three different sections: the Northern Virginia East, Northern Virginia West and Northern Virginia Central. Over the past 44 years the Northern Virginia Amateur has developed as one of the premier amateur championships in the Commonwealth of Virginia. The VSGA now recognizes the Northern Virginia Amateur as a points event counting towards their player of the year standings. This year’s championship will host Virginia’s best amateur golfers competing to win the Henry Kerfoot Trophy.

## ELIGIBILITY

A contestant must be an amateur and a member of a VSGA club or association (see Tier II and III clubs at [www.vsga.org](http://www.vsga.org)). Acceptance of an entry will be based upon handicap. Entries are subject to rejection at any time (including during the Championship) by the tournament committee. The reason for rejection may include unbecoming conduct.

Entries close on Tuesday, July 31st, 2018

Entry fee will be refunded regardless of reason if notification is given before the close of entries. After the close of entries, entry fees will not be refunded for those who withdraw.

## FIELD SIZE:

The field is limited to 108 players. The list of competitors will be posted on the website and emailed to all competitors shortly after the close of entries. Those not making the field will be notified of their position on the list of alternates.

## CUT:

Field will be cut to the low 40 players and ties after the first round.

**SCHEDULE:**

54 holes of stroke play with 18 holes scheduled for each day.

First Round: Friday, August 3, 2018, 8:30 AM shotgun start  
Second Round: Saturday, August 4, 2018, tee times start approximately 10:00 AM  
Final Round: Sunday, August 5, 2018, tee times start approximately 10:00 AM

**AWARDS, TIES AND PLAYOFFS:**

Winner – receives possession of the Henry Kerfoot Trophy for one year after their name is engraved on the trophy. Gift certificates will be awarded for approximately the top 20 places. Ties for all places except 1<sup>st</sup> will be broken by the USGA recommended method. In the event of a tie for the Championship, the winner shall be determined immediately by a sudden death playoff.

**RULES OF GOLF, NOTICE TO PLAYERS AND CLOSE OF COMPETITION:**

Play will be governed by the Rules of Golf as approved by the USGA. Local rules and conditions will be covered in the "Notice to Players." The competition closes when the championship prize has been awarded.

**FOOTWEAR (including during practice rounds):**

It is a condition of the competition that shoes with traditionally designed spikes (regardless of the composition, i.e. ceramic, plastic, etc.) or spikes, regardless of design, comprised either entirely or partially of metal (if such metal may come in contact with the course) are prohibited during the stipulated round. Penalty for breach: Disqualification.

**GOLF BALLS/DRIVER HEADS:**

Only brands of golf balls and models/lofts of driver heads on the most current UGSA confirming lists shall be used.

**PRACTICE:**

Competitors may play a discounted practice round. Bull Run will allow practice rounds for discounted rate of \$35 per player after 1:00 PM any day of the week from 7/16 to 8/2. Competitors must make tee times in advance with the pro shop by calling 703-753-7777.

**ENTRY FEES:**

Players shall apply on the attached form. Entry must be accompanied by the entry fee of **\$150** per player made payable to "**VSGA Northeast Section.**" That fee includes the fees for the first round of play, lunch after the first round, cart fees for the first round, gift certificates for the top place finishers. The second and third round cart fees are to be paid by each competitor prior to the beginning of the 2<sup>nd</sup> round (\$25.00 per day)
